Circular 3/2004: Subsistence Allowances Abroad

A Dhuine Uasail

1. I am directed by the Minister for Finance to refer to the rates of subsistence allowance payable to civil servants in respect of absences abroad on official business, as set out in the Appendix to Circular 26/2003. These rates have been reviewed and where appropriate revised, as indicated in the Appendix to this Circular. The revised rates are effective from 1 January 2004. However, in any case where the application of these rates as and from that date would result in a reduction in the total amount payable to an officer by way of subsistence in respect of a visit abroad, this Circular may, in that case, be deemed to take effect from 31 January 2004.

2. Expenditure on travel and subsistence must continue to be strictly appraised and monitored. Officers who travel abroad should limit reimbursable expenditure to the minimum consistent with the requirements of the visit. Heads of Departments should continue to ensure that only essential travel is undertaken and that the number of officers on any official journey is kept to the absolute minimum.

10 hours rate = vouched cost of 2 meals. 5 hours rate = vouched cost of 1 meal.

3. Night Rate = Vouched cost of accommodation (room only), plus the allowance indicated.

4. Night Rate = Vouched cost of accommodation and breakfast to a limit of €135 euro plus allowance indicated.

5. Night Rate = Vouched cost of accommodation and breakfast to a limit of €89 euro plus allowance indicated.

6. Weekend = Friday, Saturday and Sunday

7. Night Rate = Vouched cost of accommodation and breakfast to a limit of €105 euro (B&B limit), plus amount indicated.

8. Night Rate = Vouched cost of accommodation and breakfast plus amount indicated.
