

Re: Statutory Instrument no 547/2015 - Public Service Pension Rights (No 2) Order 2015

I am directed by the Minister for Public Expenditure and Reform to convey the following information to Departments in relation to the application of the extension of the pension 'grace period' as provided for under Section 9 of the Financial Emergency Measures in Public Interest Act 2013 (No 18 of 2013).

An order (S.I. 547/2015) has been made under the terms of the 2013 Act extending, up to 1 April 2019, the 'grace period' for calculation of pension benefits awarded to retiring public servants. Consequently an officer who retires on or before 1 April 2019 will have his or her superannuation benefits calculated by reference to the scales applying on 30 June 2013.

# PUBLIC SERVICE PENSION RIGHTS (NO.2) ORDER 2015

- I, BRENDAN HOWLIN, Minister for Public Expenditure and Reform, in exercise of the powers conferred on me by section 9(1)(b)(ii) of the Financial Emergency Measures in the Public Interest Act 2013 (No. 18 of 2013) and having taken into account such legal, superannuation and personnel management issues affecting public service bodies as I consider appropriate and having consulted the bodies or other persons that I consider appropriate, hereby order as follows:
- 1. This Order may be cited as the Public Service Pension Rights (No.2) Order 2015.
- 2. The later date specified for the purposes of section 9(1)(b)(ii) of the Financial Emergency Measures in the Public Interest Act 2013 (No 18 of 2013) is 1 April 2019.
- 3. The Public Service Pension Rights Order 2015 (S.I. No.145 of 2015) is revoked.
