General Council Report 1373

(Meeting/s of 26 July 2000, 29 November 2000)

That the Domestic Subsistence Rates be increased with effect from 1/1/2000 on the basis of the agreed formula.

Subsistence Rates

- 1. In accordance with the agreement in 1978 with the Staff Side at the General Council under the Conciliation and Arbitration Scheme, the rates of subsistence for travel within Ireland fall to be revised annually by reference to average accommodation and meal charges in an agreed list of hotels.
- 2. Following the T&S Subcommittee meeting of 28 August, 2000 it was agreed that the current home subsistence allowances should be revised in accordance with the 1978 agreement with effect from 1 January, 2000 and that a report would be drawn up to that effect.
- 3. At a General Council meeting of 29 November, 2000 the report of the Subcommittee (attached) was before the Council. It was agreed to recommend that effect be given to this recommendation contained in Paragraph 4 of that report.
- 4. This report was adopted on 29 November, 2000.

Revision of Home Subsistence Allowance Report of the General Council Subcommittee on Travelling and Subsistence

- 1. At a meeting of the T&S Subcommittee on 28 August, 2000 the Official Side confirmed to the Staff Side that they would be using the same formula for lunch prices as last year i.e. (25% of the B&B price) as they were unable to source lunch prices. The Official Side furnished Staff Side with a list of replacement hotels and subsequently the full agreed list of the 90 hotels chosen for the review.
- 2. The methodology used for the purpose of calculating the increase in the overnight rate and the day rate was the same compared with the 1999 review.

3. 8 hotels fell to be replaced. The following amendments to the agreed list of 90 hotels used in calculating the 1999 subsistence rates were agreed.
