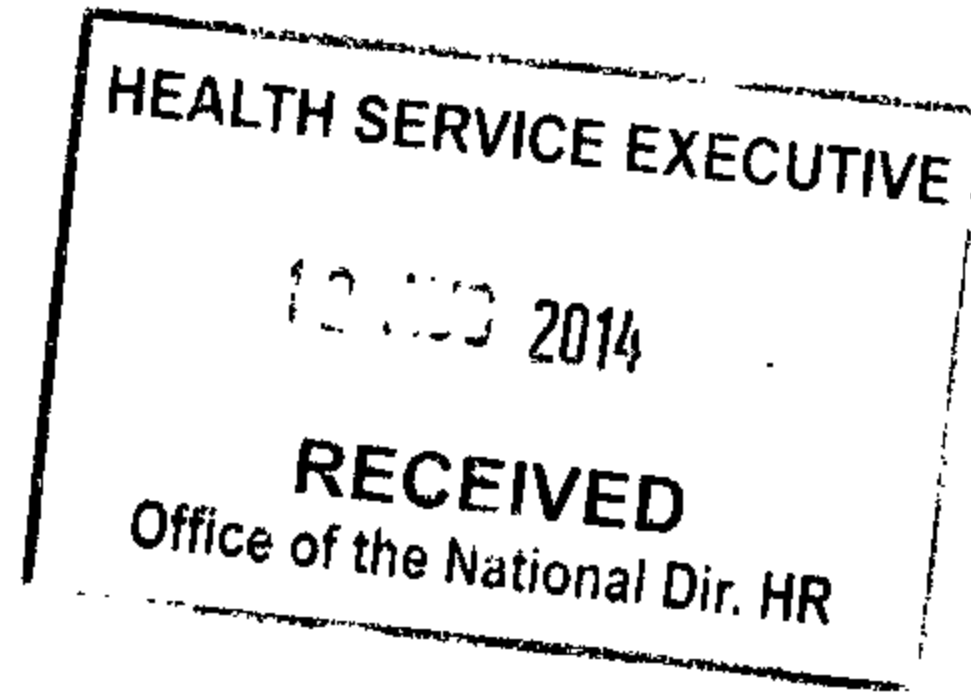

1st November 2013 Pay Scales –
Correction to Trainee Clinical Psychologists pay scale (now 3 pt scale)

Dear Mr O'Brien

Please note that the 1st November 2013 pay scales provided for a 5 point scale for the grade of Trainee Clinical Psychologists in error. Below are details of the revised 3 point scale.

The first point is the first point from the 2011 pay scale. The second point is the average of the second and third points from the 2011 pay scale. The third point is the third point of the 2010 pay scale.

	1 st Pt	2 nd Pt	3 rd Pt
Trainee Clinical Psychologist	€32,185	€34,730	€39,525

Those appointed prior to 1/1/11 and currently on the 2010 scale should remain on their current salary on an off point if necessary.

Please ensure that this circular should be brought to the attention of all relevant HSE Managers and to all service providers funded by the HSE under Section 38 of the Health Act 2004.
